No. 4172-11-672007 passed out in June, 2013.

Her provisional No.PC.104340 appears sane as the provisional certificate of Shaik Mohammad Yasar. However the Roll.No. 2167-11-672007 does not exist in MGU jurisdiction.

I would kindly request that your esteemed office investigates this matter thoroughly and takes appropriate legal action to prevent any further fraudulent activities.
